

BAPA +40: The Future of Work,

Youth Employment and South-South Cooperation

ILO- South Centre- *Buenos Aires, Law Faculty, UBA, Salón Verde, 21 March, 2019, 8.30 – 10.15am*

I) Background

A milestone event in the history of South-South and triangular cooperation (SSTC) in the UN was the first UN Conference on Technical Cooperation between Developing Countries (TCDC) in Buenos Aires, Argentina in 1978. This conference gathered 138 Ministers of Foreign Affairs of the Global South to adopt the **Buenos Aires Plan of Action (BAPA)**, the first SSTC framework. The Second High-level United Nations Conference on South-South cooperation (BAPA+40), is an opportunity to assess progress in South-South Cooperation in the UN system. In preparation for BAPA+40, on the 1 November 2018, the ILO, in collaboration with the South Centre and UNCTAD, co-hosted a consultation meeting among twenty Geneva- and Rome-based agencies to agree on key topics for the discussion in BAPA+40, including youth employment.

During BAPA+40, the ILO and the South Centre are organising a side event entitled “*The Future of Work, Youth Employment and South-South Cooperation*”. As a contribution to the BAPA+40 and in harmonisation with ILO’s Centenary celebration, this event will revolve around two strategic themes of Youth Employment and the Future of Work. Young people are considered as the world’s driver of change and a key stakeholder in the realisation of the Agenda 2030. On Monday 24th September 2018, the UN Secretary-General officially launched the Youth2030: The United Nations Youth Strategy at the UN Headquarters in New York. The strategy guides the UN system in stepping up support for the empowerment of young people, while ensuring that the Organization’s work fully benefits from their insights and ideas.

At the 316th Session of the ILO Governing Body in November 2012, a seven-year Follow-up Plan was endorsed giving effect to the provisions of the aforementioned Resolution. The Plan emphasised the need to explore “**opportunities to extend South–South and triangular collaboration to include youth employment**” as called for by the resolution.¹ In 2016, the Global Initiative on Decent Jobs for Youth was launched to scale up action and impact on youth employment in support of the 2030 Agenda.

Against this backdrop, this panel discussion will look into the challenges of young men and women in the changing context of the Future of Work. The Global Commission on the Future of Work launched on the 22nd of January 2019 its report, and one of the axis of its “**Human-Centred Agenda**” is “increase investment in peoples’ capabilities, and describes it is critical to: “Step up investments in the institutions, policies and strategies that will support people through future of work transitions, **building pathways for youth into labour markets** (...)”. This reaffirms the importance of a youth-centred development cooperation. The panel will also take into account the elements of the Financing for Development agenda, present in the Addis Ababa Action Agenda (AAAA), which focus on youth and South-South cooperation.

II. Objectives of the Panel:

The main objective of the discussion will be to **link the future of work reflection with the South-South and triangular cooperation and new paths for youth employment policies post BAPA + 40**. The ILO has organised its Future of Work dialogues around four Centenary Conversations, which include, “*work and society*”, “*decent jobs for all*” in a sustainable economy; “*the organization of work and production*”; “*the Governance of Work*”, which highlights the values of tripartism and social dialogue, with the critical question of youth employment. The panel will focus on the Global South

perspectives contained in the second dialogue of “decent jobs for all”, with a concentration on youth employment. Specifically, the three following topics will be discussed by the panellists, with one specific question to be addressed and one common focus (recommendations for BAPA +40 participants):

1. **Future of Work, Youth employment policies and skills development:** the panel will take into consideration youth employment and skills development policies to advance the 2030 Agenda for Sustainable Development in the context of SSTC. The discussion will aim to answer the following questions: (1) *Considering the report on the Future of Work produced by the Global Commission, what are the most relevant issues regarding youth employment in the Global South and what can be the contribution of SSTC?*
2. **Green jobs for youth through SSTC:** the panel will identify bottlenecks that prevent countries to fully tap market, trade and employment opportunities in transitioning to a greener economy. The panel will also take on board current socio-economic SSTC policies to promote good practices to foster economic growth, through the creation of decent green jobs. The following question will be addressed by the panellist: *what is your point of view about the linkages between green jobs for youth and South-South and triangular cooperation?*
3. **Youth employment, Future of Work and social dialogue:** With the presents of employers’ and worker’s representatives, the panel will discuss social dialogue and its key role in ensuring full participation of social partners in the future world of work, including the many millions of youth workers who are currently excluded. It will reflect the views of panellists on the impacts of tripartite governance and SSTC in supporting decent youth employment in the future. A key question will be: *What is the role of social partners from the global south to promote SSTC and youth employment?*

All panellists will provide recommendations for the BAPA + 40 participants on integration of Youth Employment into South-South and triangular cooperation policies.

- **Future of Work, youth employment and Social Dialogue in the Global South:** *Workers’ and Employers’ perspectives, Employers’ and Workers’ from the Americas*

The panellists will discuss the roles of workers’ and employers’ organisations, social dialogue, and tripartite governance in promoting decent work and inclusion of youth in the future world of work.
